Rare Earth Oxide is a mixture of Cerium Oxide (1306-38-3), Lanthanum Oxide (1312-81-8), Praseodymium Oxide (12037-29-5), and Neodymium Oxide (1313-97-9). Rare Earth Fluoride is a mixture of Cerium Fluoride (7758-88-5) and Lanthanum Fluoride (13709-38-1).
